TWO ORGANIZATIONS, ONE PURPOSE: HELPING YOUNG PEOPLE CHANGE THEIR COMMUNITIES FOR GOOD

e're sparking a youth-led renaissance," declared Nicole Fenichel-Hewitt, Executive Director of The Art Effect in Poughkeepsie, happily expressing her enthusiasm for the dramatic transformation happening both within her organization and in the surrounding neighborhood. "In case you haven't noticed, there's a community revival going on, led by visionary young people with a purpose."

"I have never seen such community commitment, across every segment, affecting such positive change, and our youngest are among those leading, with honesty and sincerity, from within a most affected segment," Fenichel-Hewitt explained. These sentiments are echoed by Laurie Sigalos, Executive Director of the Philipstown Behavioral Health Hub (the Hub) in Cold Spring, who stated that the Hub's success in addressing local mental health and addiction issues in large part comes from engaging young people in its programs and outreach efforts.

Like so many of the nonprofits supported by the Community Foundations of the Hudson Valley, these two hard-working organizations are catalysts for systematic change right in their own neighborhoods. Both The Art Effect and the Hub focus on creating safe places for individuals to express themselves and benefit from services as they explore and create solutions, both within themselves and in their communities.

For example, after being awarded a \$100,000 grant from the National Endowment for the Arts' Our Town Program, The Art Effect established a "Youth Arts Empowerment Zone" in the City of Poughkeepsie for the purpose of using the arts to strengthen communities, advance economic and social outcomes, and create sustainable change. Over three days in September, The Art Effect sponsored its first student-led PKX Festival, attracting over 700 people. The festival featured sidewalk painting, a gallery exhibition, teen dance party, musical performances, food vendors, entertainment and a wide variety of art-making activities from community partners. Artwork from this and future events will become permanent neighborhood installations. Fenichel-Hewitt reported that an unhoused individual told her, "The art made my day." Another gave her a cheer of "Art, Art, Art!" Likewise, at the Hub, efforts to erase the stigmatization of mental health and addiction are making great strides because young people are involved. The Hub is partnering with local school districts to provide in-school prevention programs and classes for students at the Hub's office. Sigalos said she has never seen a community come together with such mutual conviction as in addressing the current addiction crisis, and that people are particularly listening to their local youth's voices.

Praising young people's dedication to bringing about real change, Fenichel-Hewitt said, "They have a way of looking at things more simply than some of their older counterparts. They just figure out how to get things done." Case in point: The Art Effect recently added two students to their board, and the Hub is working with an Eagle Scout on an awareness campaign that empowers kids to ask for help when they are struggling, which Sigalos hopes will become a model for other organizations.

Although they lead two very different organizations, Fenichel-Hewitt and Sigalos both agree that the key to strengthening a community and pointing it toward a brighter future lies in collaborating with the leaders of today and tomorrow. They are both grateful for the Community Foundations' funders and donors who truly are making a better future possible for all of us.

CHARITABLE LEGACY GIFTS \$1.3B+ COULD COME TO THE HUDSON VALLEY

When wealth leaves the community, it may be gone forever. If our wealth is endowed in our community, it is here forever.

he Community Foundations of the Hudson Valley recently commissioned research to estimate how much of our region's resources will transfer between generations within the next 10 and 50 years. The study provides key insights into the opportunities created by the largest ever intergenerational transfer of wealth.

The study found that today, our region has a current household net worth of \$275 billion. That includes real estate, retirement, savings, checking, stock accounts, and other noncash assets. Over the course of the next 10 years, an estimated \$25.5 billion will pass from one generation to the next. This is a once in a generation chance to increase investments in nonprofit organizations through legacy gifts. If merely 5% of this transfer goes to local charities, it would total more than \$1.3 billion. The impact that these legacy gifts could have on our community are significant, but we must capture them NOW.

This transfer represents enormous untapped potential for charitable organizations. This is a critical time for nonprofit leaders to lean into promoting planned gifts. An important first step is for nonprofits to educate donors about what their legacy gifts would mean to the organization and the community. It's also important to remember that professional advisors, like attorneys, are key to helping their clients include charitable gifts in their estate plans.

A sustained effort from nonprofits to capture some of the transfer will mean more resources in their future, but it needs to start now.

We asked several of our region's most respected voices to share their views on how this transfer of wealth can benefit nonprofit organizations, charitable individuals and families, and the community at large. The impact that these legacy gifts could have on our community are significant, but we must capture them NOW.


BENEFITS FOR OUR COMMUNITY




