Estate Planning During Covid and Beyond

Has the COVID 19 pandemic affected estate planning?

The COVID 19 pandemic heightened concern for estate planning. The current crisis may be passing, but estate planning is constantly changing. People should monitor their estate plans and keep them up to date.

What changes might impact my estate planning in 2021?

One recent change is the SECURE Act, which took effect last year. It

reduced the number of years that a beneficiary family member (other than a surviving spouse) could stretch out an inherited IRA. Funds from these accounts will be taxable as ordinary income when withdrawn by the beneficiary.

What are tax efficient ways I can make charitable contributions during my retirement?

Tax-deferred IRA's and similar retirement accounts can be a taxadvantaged way to meet your charitable goals. If you are over age 70 ½, you can make a Qualified Charitable Distribution (QCDs) of up to \$100,000 per year directly to your favorite charity. Such QCD's may count against your Required Minimum Distribution (RMD). Naming the charity as beneficiary on an IRA will allow the IRA to pass

to the charity at your death free of income tax.

Each person's situation is different. We recommend that you meet with your attorney, accountant and/ or financial advisor to review your personal estate plan in light of current developments. For those of you who are charitably minded, the Community Foundations of the Hudson Valley can be an excellent team member to assist in the planning process and as a vehicle to achieve your charitable objectives in our community.

Dutchess Responds grants from

and deliver 14,000 pounds of food
